



## THE FUTURE OF THE PROFESSION

**ARTICLING TASK FORCE CONSULTATION**—In December 2011, Convocation decided to consult with the Profession in respect of the Articling Task Force Report. The Profession and interested parties are encouraged to review the report and submit written comments. The goal of the consultation is to consider practical solutions to the issues the Consultation Report raises.

**Subject to the consultation, identified options currently are:**

**Option 1**—Status quo.

**Option 2**—Status quo with added Quality Assurance Improvements.

**Option 3**—Abolishing articling but in certain circumstances replacing it with post-licensing transitional learning.

### Creation of a Practical Legal Training Course:

**Option 4**—As an alternative, for those students who do not article; **OR**

**Option 5**—For all students to replace articling.

### The questions being examined are:

1. Should transitional training form part of the Law Society's licensing requirements as discussed in the Consultation Report?
2. If so, has the Task Force accurately described the goals of transitional training as part of the Law Society's licensing process?
3. As a regulatory requirement, should transitional training have established standards against which students are assessed? If so, how does the current articling requirement accomplish this?
4. Should the Law Society address the issue of articling placement shortages and, if so, how?
5. What are your views on the introduction of financial incentives to encourage increased articling placements? Should Law Society fees fund such incentives?
6. What are your views on introducing a system specifically designed to hire articling students under the supervision of lawyers to provide access to justice to low income Ontarians, equality-seeking groups and regions outside the major metropolitan centres? What is your view of such an initiative being funded through law society fees?
7. Should successful completion of the licensing examinations be a prerequisite to commencing transitional training?
8. What are your views on the five options presented in the Consultation Report?
9. What are your views on the issue of over-representation of equity-seeking groups in those not able to obtain articling positions?
10. If you have concerns, do any of the proposed 5 options satisfactorily address those concerns?
